## Introduction

This scheme of work has been designed to support you in your teaching and lesson planning. Making full use of this scheme of work will help you to improve both your teaching and your learners' potential. It is important to have a scheme of work in place in order for you to guarantee that the syllabus is covered fully. You can choose what approach to take and you know the nature of your institution and the levels of ability of your learners. What follows is just one possible approach you could take and you should always check the syllabus for the content of your course.

Suggestions for independent study **(I)** and formative assessment **(F)** are included.

Opportunities for differentiation are indicated as **Extension activities**; there is the potential for differentiation by resource, grouping, expected level of outcome, and degree of support by teacher, throughout the scheme of work. Timings for activities and feedback are left to the judgment of the teacher, according to the level of the learners and size of the class. Length of time allocated to a task is another possible area for differentiation.

### Guided learning hours

Guided learning hours give an indication of the amount of contact time you need to have with your learners to deliver a course. Our syllabuses are designed around 130 hours for Cambridge IGCSE / O Level courses. The number of hours may vary depending on local practice and your learners' previous experience of the subject. The table below give some guidance about how many hours we recommend you spend on each topic area.

Earth: the operators’</p> <p>Learners write down one reason on wipe boards or paper why fossil fuels are and then share with whole class <b>(F)</b>.</p> <p><b>Extension activity:</b> Use the internet/textbooks to research why burning fossil fuels is an environmental concern, e.g. <a href="http://www.epa.gov/ghgemissions/global-greenhouse-gas-emissions-data">www.epa.gov/ghgemissions/global-greenhouse-gas-emissions-data</a> <b>(I)</b>.</p>

**Independent study (I)** gives your learners the opportunity to develop their own ideas and understanding without direct input from you.

**Extension activities** provide your more able learners with further challenge beyond the basic content of the course. Innovation and independent learning are the basis of these activities.

**Past papers, specimen papers** and **mark schemes** are available for you to download from the [School Support Hub](#). Using these resources with your learners allows you to check their progress and give them confidence and understanding.

**Formative assessment (F)** is on-going assessment which informs you about the progress of your learners. Don’t forget to leave time to review what your learners have learnt, you could try question and answer, tests, quizzes, ‘mind maps’, or ‘concept maps’. These kinds of activities can be found in the scheme of work.

## 1. Rocks and minerals and their exploitation

1.1 Formation of rocks	<ul style="list-style-type: none"> <li>• state and explain the formation and characteristics of named igneous, sedimentary and metamorphic rocks</li>   <li>• describe and interpret the rock cycle</li> </ul>	<p>Introduce the topic by looking at samples of igneous, sedimentary and metamorphic rock for learners to observe the key characteristics and differences. If possible, look at samples of granite and basalt, limestone, sandstone, shale, marble and slate. This could be small samples of rock or buildings in the local neighbourhood. Learners could be given a key to the characteristics of each type of rock and then categorise the samples into rock type <b>(I)</b>.</p> <p>Chocolate rock cycle: using chocolate to 'create' sedimentary, metamorphic and igneous chocolate. <i>Safety: check for potential allergies to chocolate amongst learners.</i> In <a href="http://www.geolsoc.org.uk/">www.geolsoc.org.uk/</a> – search for 'chocolate rock cycle'.</p> <p>Interactive rock cycle, such as in <a href="http://www.learner.org/">www.learner.org/</a> – search for 'rock cycle'.</p> <p><b>Extension activity:</b> Learners produce photo/image board of rock types near their homes.</p> <p>Use wipe boards for 'quick fire' quiz on main characteristics of the three rock types and the rock cycle <b>(F)</b>.</p>

2.2 Energy resources and the generation of electricity	<ul style="list-style-type: none"> <li>classify the following energy resources as non-renewable or renewable:             <ul style="list-style-type: none"> <li>non-renewable: fossil fuels, nuclear power using uranium</li> <li>renewable: biofuels (bioethanol, biogas and wood), geothermal power, hydro-electric power, tidal power, wave power, solar power, wind power</li> </ul> </li> </ul>	<p>Learners produce a mind map of the renewable and non-renewable energy resources and how each of the energy resources is used to generate electricity.</p> <p>This can be achieved on paper or electronically on a free app, such as <a href="http://mindmapfree.com/">http://mindmapfree.com/</a> or <a href="http://www.edrawsoft.com/freemind.php">www.edrawsoft.com/freemind.php</a> or other suitable software or app (F).</p> <p>Possible resources:  <a href="http://www.eia.gov">www.eia.gov</a> – search 'What is energy? Possible resource: <b>www.electrical4u.com</b> – search ‘electrical power generation’.</p> <p>Learners watch the clip and then compare values of energy use, recycling and carbon footprints from Poland and the UK or other EU countries. Learners present their findings in an information leaflet <b>(I)</b>. <b>www.bbc.co.uk/education</b> – search ‘Environmental problems in Poland’.</p> <p>In groups, learners compare and contrast one renewable and one non-renewable resource and present their findings to the class. 2.3 Energy demand	<ul style="list-style-type: none"> <li>• describe and explain the factors affecting the demand for energy <ul style="list-style-type: none"> <li>– domestic demand</li> <li>– industrial demand</li> <li>– transport</li> <li>– personal and national wealth</li> <li>– climate</li> </ul> </li> </ul>	<p>Learners summarise the data for energy consumption by source and sector from a suitable data source, such as <b>www.eia.gov</b> – search ‘Energy explained, your guide to understanding’.</p> <p><b>www.nap.edu/</b> – search ‘What you need to know about energy’.</p> <p>Learner pairs role play by pretending to be:</p> <ul style="list-style-type: none"> <li>• from a MEDC and LEDC</li> <li>• from a country in a hot and cold climate</li> <li>• living in a rural and urban location</li> </ul> <p>and explain to each other their energy needs. At the end they should produce a summary of the differences and similarities for each role play <b>(I)</b>.</p>

2.4 Conservation and management of energy resources	<ul style="list-style-type: none"> <li>• describe and explain strategies for the efficient management of energy resources               <ul style="list-style-type: none"> <li>– reducing consumption, such as using insulation, turning electrical devices off and using energy efficient devices and vehicles</li> <li>– energy from waste cooking oil</li> <li>– exploiting existing energy sources</li> <li>– education of people for energy conservation</li> <li>– transport policies</li> </ul> </li> <li>• research and development of new energy resources               <ul style="list-style-type: none"> <li>– fracking</li> </ul> </li> </ul>	<p>Learners produce a development plan for a small town on strategies for efficient management of energy resources. Possible resource: <b><a href="http://www.carbontrust.com/media/7385/ctv045_an_introduction_to_energy_management.pdf">www.carbontrust.com/media/7385/ctv045_an_introduction_to_energy_management.pdf</a></b> Learners undertake a survey of energy efficiency in their own homes and report back their findings.</p> <p><b>Extension activity:</b> Learners estimate how much the school could save if all the lights in the building were energy efficient.</p> <p>Learners answer the following question: 'Fracking is the answer to our energy needs.' 2.5 Impact of oil pollution	<ul style="list-style-type: none"> <li>• describe the causes and impacts of oil pollution on marine and coastal ecosystems               <ul style="list-style-type: none"> <li>– causes: off-shore oil extraction, pipelines and shipping</li> </ul> </li> </ul>	<p>Learners do an experiment on what happens during an oil spill. This could include dipping feathers into the 'oil spill' to see the potential effect on birds. <i>Care should be taken when dealing with any oil products and an appropriate risk assessment must be carried out.</i> Possible resource: <b><a href="http://weirdsciencekids.com">http://weirdsciencekids.com</a></b> – search for 'Oil spill experiment'.</p> <p>Give the learners a food chain and ask them: 'How would an oil spill affect this food chain?' This could be extended to: 'How would an oil spill affect a named ecosystem?' Learners could be given photographs of the ecosystem or organisms in the food chain as a stimulus.</p> <p>Learners write an article for a children's science magazine on the impact of a major oil spill <b>(I)</b>. Possible resources:</p>

2.6 Management of oil pollution	<ul style="list-style-type: none"> <li>• discuss strategies for reducing oil spills in marine and coastal ecosystems</li>   <li>• discuss strategies for minimising the impacts of oil spills on the marine and coastal ecosystems <ul style="list-style-type: none"> <li>– MARPOL (International Convention for the Prevention of Pollution from Ships)</li> <li>– double-hulled oil tankers</li> <li>– dealing with oil spills (booms, detergent sprays, skimmers)</li> </ul> </li> </ul>	<p>Learners do an experiment on how to clean up an oil spill. This could be using a jug or spoon to act as a skimmer, a piece of string or chord to represent a boom and detergent to break the spill into smaller particles.  Possible resource: <a href="http://www.amsa.gov.au/">www.amsa.gov.au/</a> – search for ‘Experiment to clean up an oil spill’.  <i>Care should be taken when dealing with any oil products and an appropriate risk assessment must be carried out.</i></p> <p>Learners look at data for the number of major oil tanker spills compared with the quantity of seaborne oil trade and describe the data.  Learners look at a graph of causes of large oil spills and summarise the data.  Learners draw a bar graph of the top 20 major oil spills and the quantity of oil spilt.</p> <p>Possible data: <a href="http://www.itopf.com/knowledge-resources/data-statistics/statistics">www.itopf.com/knowledge-resources/data-statistics/statistics</a></p> <p>Learners imagine that they run an oil-spill clean-up company. They have just been told that an oil spill has occurred 20 miles off the coast of their country. What will they do?
